### Update on Port Dickinson Shots Fired Investigation

(PORT DICKINSON, NY) On February 11, 2024, Port Dickinson Police and Broome County Sheriff's Deputies responded to the area of Chenango St. and Beacon St. in the Village of Port Dickinson for a report of gunfire and possible domestic dispute.

Upon arrival of law enforcement, a female victim was located near the scene with minor injuries stemming from a dispute with her boyfriend. Her boyfriend was located shortly afterwards a few blocks away. Law enforcement members at the scene located several handgun shell casings in the area of the dispute between the parties.

Both parties sustained minor injuries and the female was transported to a nearby hospital for treatment and subsequent release. Neither party was cooperative with the investigation and the handgun used to fire the shots was not located. Chenango St. was closed for a few hours while Detectives from the Sheriff's Office processed the scene and canvassed the area for property damage and witnesses.

No person sustained injuries from the firearm being discharged and no charges have been filed at this time.

### **Separate DWI Charges**

During the initial crime scene investigation, a vehicle struck a NYSP Trooper car that was blocking the roadway to the scene and subsequently drove through the scene, nearly striking a Detective. That vehicle was located nearby and the operator, Helene B. Delnegro, age 37 of Port Dickinson, NY, was taken into custody by NYSP for DWI. Additional charges were filed by the Sheriff's Office: Reckless Endangerment in the 2<sup>nd</sup> Degree, a Class A Misdemeanor and Obstructing Governmental Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor.
