The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Margaret A. Will, age 39 of Windsor, NY was arrested on an outstanding warrant and charged with Bail Jumping in the 3<sup>rd</sup> Degree, a Class A Misdemeanor after failing to appear in court multiple times to answer for separate petit larceny charges in the Town of Windsor.

Rachel M. Morales, age 51 of Windsor, NY was arrested for Criminal Possession of Stolen Property in the 5<sup>th</sup> Degree, a Class A Misdemeanor, following an arrest on an outstanding warrant following a larceny investigation in the Town of Windsor.

Roy Eherts IV, age 48 of Windsor, NY and Susan A. Eherts, age 57 of Windsor, NY were both charged with two counts of Endangering the Welfare of a Child, Class A Misdemeanors following a child abuse investigation in the Town of Windsor.

Delnegro, age 37 of Port Dickinson, NY was charged by the Broome County Sheriff's Office with Reckless Endangerment in the 2<sup>nd</sup> Degree, a Class A Misdemeanor and Obstructing Governmental Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor after driving through an active crime scene while fleeing police. Delnegro was taken into custody by New York State Police on separate charges related to his incident.

Melina A. Borgos, age 19 of Johnson City, NY was charged with Disorderly Conduct/Unreasonable Noise, a Violation, following an arrest on an outstanding warrant after failing to appear in court to answer for separate Disorderly Conduct and Drinking Alcohol in a Motor Vehicle on a Highway charges in the Town of Chenango.

Daniel D. Ackley, age 59 of Johnson City, NY was charged with Menacing in the 2<sup>nd</sup> Degree (With a Weapon), a Class A Misdemeanor and Reckless Endangerment in the 2<sup>nd</sup> Degree, a Class A Misdemeanor following an investigation of a fight in the Town of Dickinson.
