RESOLUTION NO. 456

By Finance and County Administration, Economic Development & Planning Seconded by Mr. Miller

RESOLUTIÓN AUTHORIZING INTERGOVERNMENTAL AGREEMENT ESTABLISHING THE BROOME COUNTY ECONOMIC DEVELOPMENT ZONE BOARD

WHEREAS, portions of the Town of Union, Villages of Johnson City and Endicott and City of Binghamton have previously been designated the Triple Cities Economic Development Zone, and

WHEREAS, a new economic development zone has been created encompassing portions of the City of Binghamton and Town of Kirkwood, and

WHEREAS, these economic development zones will become one zone and the member communities of the zones desire to enter into an intergovernmental agreement pursuant to

Article 5-G of the General Municipal Law providing for the establishment of a unified local zone administrative board to administer the economic development zone, and

WHEREAS, the State of New York will annually determine a cash contribution toward the cost of the administration of the unified Broome County Economic Development Zone with the member communities matching the State cash contribution, now, therefore, be it

RESOLVED, that this County Legislature hereby authorizes, pursuant to Article 5-G of the General Municipal Law, an intergovernmental agreement between the County, the Town of Union, Village of Endicott, Village of Johnson City, City of Binghamton and Town of Kirkwood (the "member communities") which agreement, pursuant to Section 963 of the General Municipal Law, shall provide for a joint economic development administrative board to administer all economic development zones within the member communities to be known as the "Broome County Economic Development Zone Administrative Board", and be it

FURTHER RESOLVED, that this County Legislature hereby adopts the proposed program budget for the County's share of the Broome County Economic Development Zone Administrative Board budget for the period July 1, 1998 through June 30, 1999 as set forth in Exhibit "A" annexed hereto and authorizes a cash match contribution from the County pursuant to said budget not to exceed \$2,634.00 to be paid from budget line 440016.4545 (Contracted Services), and be it

FURTHER RESOLVED, that future cash match contributions from Broome County to fund its share of the expenses of the Broome County Economic Development Zone Administrative Board shall be limited to the previous year's appropriation unless otherwise appropriated by this County Legislature, and be it

FURTHER RESOLVED, that the County Executive or his duly authorized representative is hereby empowered to execute any such agreements, documents, or papers, approved as to form by the Department of Law, as may be necessary to implement the intent and purpose of this Resolution.
