# BROOME COUNTY LEGISLATURE SPECIAL SESSION MONDAY, NOVEMBER 8, 1999

The Legislature convened at 6:05pm with a call to order by the Chair, Daniel A. Schofield. The Clerk, Louis P. Augostini, read the fire exit announcement and called the Attendance Roll, Present-18, Absent-1 (Mather).

The Chair, Mr. Schofield, led the members of the Legislature in the Pledge of Allegiance to the Flag, followed by a prayer offered by Legislator Hudak.

Mr. Howard and Mr. Pasquale were designated as participants in the 'Short Roll Call.'

The Chair, Mr. Schofield, indicated that the purpose of this session was to receive a report from the Finance Committee concerning the Proposed 2000 Broome County Budget. Mr. Schofield indicated that the Legislature would start with a review of the Finance Committee Report, to be followed by consideration of motions from individuals.

Mr. Wike, Chair of the Finance Committee, made the following motion, seconded by Mr. Howard.

"I move the report of the Finance Committee, amending the 2000 Proposed Budget. The Budget Office is authorized to make the appropriate adjustments to each departmental fringe benefit section based on increases or decreases in any salary lines that are adopted by this County Legislature, make appropriate adjustments to chargeback lines to reflect legislative actions, and make appropriate adjustments to reimbursable revenues to reflect legislative actions."
