# BROOME COUNTY LEGISLATURE REGULAR SESSION THURSDAY, JANUARY 25, 2001

The Legislature convened at 5:02 p.m. with a call to order by the Chair, Daniel A. Schofield. The Clerk, Louis P. Augostini, read the fire exit announcement and called the Attendance Roll, Present-19. Absent-0.

WHEREAS, this County Legislature, by Resolutions 438 and 439 of 2000, authorized agreements for the Broome-Tioga Workforce Investment Area and between the counties of Broome and Tioga and the Workforce Development Board pursuant to the Workforce Investment Act, and WHEREAS, the purpose of WIA is to improve the quality of the workforce, reduce welfare dependency, and enhance the productivity and competitiveness of the area, and

WHEREAS, in order to carry out such activities of the WIA for the Broome-Tioga Workforce Investment Area, a five-year plan must be created with required attachments, including a two county agreement, a two county and workforce board agreement and a partners memorandum of understanding and such plan and attachments that may be amended during the period of the plan to meet emerging needs of industry and service delivery, and

WHEREAS, the five-year plan shall be for the period July 1, 2000 through June 30, 2005, and

WHEREAS, the plan and attachments define the services and programs to be offered in the Workforce Development System of the area to effectively match the needs and desires of those seeking employment with those employers seeking skilled and productive employees, and

WHEREAS, the plan and attachments define the partnerships between the Workforce Development Board, the two counties in the area, and elected officials, local business and civic and community leaders and community organizations to deliver the services and programs of the Workforce Development System, and

WHEREAS, the plan and attachments, and any revisions, require the signature of the County Executive or his duly authorized representative to implement the programs and services of the Broome-Tioga Workforce Development System, now, therefore, be it

RESOLVED, that this County Legislature hereby empowers the County Executive or his duly authorized representative to execute any such agreements, documents or papers approved as to form by the Department of Law as may be necessary to implement the intent and purpose of this Resolution.

#### Carried.
