RESOLUTION AUTHORIZING AGREEMENT WITH RMSCO, INC. FOR ADMINISTRATION OF THE BROOME COUNTY HEALTH AND FLEXIBLE BENEFITS PLANS FOR RISK AND INSURANCE FOR 2001-2006

WHEREAS, the Manager of Risk and Insurance requests authorization for an agreement with RMSCO, Inc. for the administration of the Broome County Health and Flexible Benefits Plans for Risk and Insurance at a cost not to exceed the budgeted appropriations, for the period September 1, 2001 through August 31, 2006, and

WHEREAS, said services are necessary for the complete administration of the Medical and Flexible Benefits plans provided to Broome County employees, now, therefore, be it

RESOLVED, that this County Legislature hereby authorizes an agreement with RMSCO, Inc., 115 Continuum Drive, Liverpool, New York 13088, for the administration of the Broome County Health and Flexible Benefits plans, for Risk and Insurance for the period September 1, 2001 through August 31, 2006, and be it

FURTHER RESOLVED, that in consideration of said services, the County shall pay the Contractor at the rates shown in the following table for the term of the agreement:
