Mr. Wilber stated that this is additional funding being provided by the State and if the additional funding goes away, the stipend will go away as well.

Mr. Cornwell stated that this Resolution and #57 are contingent upon available grant funding. Therefore, if the grant goes away, these investigators will go away. Mr. Cornwell stated that violent crimes are up in Broome County by 49% and this position is greatly needed.

#58 RESOLUTION AUTHORIZING AN AGREEMENT WITH SHAYNA R. MARSCHILOK TO ADMINISTER THE OFFICE OF THE DISTRICT ATTORNEY'S TRAFFIC DIVERSION PROGRAM FOR 2017

Mr. Cornwell stated that Ms. Marschilok has been instrumental in setting up and developing the Traffic Diversion Program and she is currently the only one who can properly manage it. He further stated that he plans to have her train current staff and that the program is on pace for bringing in a million dollars in revenue.

Mr. Cornwell stated that Probation department staff had been helping with some services but he found there could be non-compliance with HIPAA with them assisting. Because of this, he needs additional help to get back on track and the contractors through StafKings are required to sign non-disclosure agreements which would be in compliance with HIPAA. Carried.
