- **2) RMP Facilities must develop plans** for conducting Emergency Response Exercises by December 19, 2023. This consists of notification exercises, field exercises, and tabletop exercises.

Amrex Chemical has 3 RMP facilities – taking down to 2 facilities in next quarter. Binghamton Water Department? Endicott Water?

- 3) OSHA Hazard Communication Standard Update Affects all workplaces with any Hazardous Chemicals: OSHA has issued a final rule that updates the Hazard Communication Standard (HCS) to align primarily with the seventh revision of the United Nations' Globally Harmonized System of Classification and Labelling of Chemicals (GHS). Current version aligns with third version. The final rule was published on May 20, 2024, and takes effect on July 19, 2024. Some aspects have phase-in dates of compliance. See fact sheet.

- 5) Methylene Chloride ban finalized on April 30, 2024: Bans most commercial uses of Methylene Chloride (Dichloromethane). Commonly used in Aerosol degreasing, paint and coating brush cleaners, in adhesives and sealants and in the mfg. of other chemicals. *Retail sales were banned in 2019.*
