They both requested Mr. Cornwell meet with municipal leaders to answer any questions they have and to better explain the changes to the traffic diversion program.

Mr. Cornwell stated that this change is being made in order to comply with a recently enacted State Law and will allow the DA to create a trust account that he could spend at his discretion to fund the DA's Office and other expenses.

Mr. Whalen expressed concerns over authorizing an unsupervised fund which doesn't require any reporting of expenditures.

## RESOLUTION IN SUPPORT OF NEW YORK STATE LEGISLATION WITH REGARD TO SEX OFFENDER REGISTRATION

WHEREAS, on January 1996 New York State adopted the Sex Offender Registration Act (SORA) commonly known as Meghan's Law, and

WHEREAS, SORA was enacted to protect the citizens of New York State from dangerous sex offenders by requiring sex offenders to register as sex offenders in the area where they reside, and

WHEREAS, SORA has designated sex offenders in three classifications:

Level One - least likely to re-offend

Level Two - medium chance of re-offending

Level Three – high chance of re-offending

## and

WHEREAS, the 20 year registration has expired, allowing hundreds of Level 1 sex offenders to be released and free to move and roam anywhere they want to go without a way of monitoring their movements, and

WHEREAS, there are 279 Level 1 sex offenders in Broome County, and

WHEREAS, members of Broome County Legislature deem this a very dangerous practice for the residents of New York State to release Level 1 sex offenders from the registration act, and

WHEREAS, there is pending legislation currently under consideration in the New York State Legislature with regard to sex offender registration:

- Assembly Bill A.9532, which requires level one sex offenders to register for life, with a right to
  petition for relief after 30 years; and
- Senate Bill S.6066 and companion Assembly Bill A.8503, would which extend the requirement
  of level one sex offenders to register as a sex offender from twenty years to thirty years and
  would also allow local governments to place reasonable restrictions on where a sex offender is
  permitted to live;

now, therefore, be it

RESOLVED, that this County Legislature commends the New York State Senate and Assembly for the introduction of A. 9532 and S.6066/A.8503, and urges the New York State Legislature to pass said legislation, and be it

FURTHER RESOLVED, that the Clerk of the Legislature shall forward a certified copy of the resolution to Governor Andrew M. Cuomo, Senate Majority Leader John J. Flanagan, Assembly Speaker Carl E. Heastie, Senator Frederick J. Akshar II, Assemblyman Clifford W. Crouch, Assemblyman Christopher S. Friend, Assemblywoman Donna A. Lupardo, and the New York State Association of Counties.
