- #2 RESOLUTION CONFIRMING APPOINTMENT TO MEMBERSHIP ON THE BROOME COUNTY SOIL AND WATER CONSERVATION DISTRICT BOARD OF DIRECTORS As requested by Mr. Whalen, a copy of Erin Heard's resume will be provided to him. Carried. Ayes-5, Nays-0
- #3 RESOLUTION AUTHORIZING AMENDMENT TO THE AGREEMENT WITH THE BROOME COUNTY LAND BANK CORPORATION (BCLBC) FOR ADMINISTRATIVE SERVICES FOR THE DEPARTMENT OF PLANNING AND ECONOMIC DEVELOPMENT FOR 2015-2017

Responding to questions from Mr. Whalen, Mr. Martin stated that the Land Bank currently administers the grant for housing rehabilitation and blight removal and the amendment would authorize and provide funding for the Land Bank to subcontract with agencies to complete the approved rehab projects, in accordance with the Land Banks procurement policy. As requested by Mr. Whalen, Mr. Martin will check what the rules are for the disposition of the rehabilitated properties as well as provide a copy of the Land Bank's procurement policy. Carried. Mr. Sopchak questioned the by-laws for the Upstate Theater Coalition for a Fairgame, Inc. Mr. Marion explained that this allows the Forum Theater to be part of the coalition which under separate agreement will receive revenues from Tioga Downs Racetrack, LLC which are estimated to be around \$35,000 for Broome County and will begin in 2017.
