#54 RESOLUTION ADOPTING LOCAL LAW INTRO. NO. 4 OF 2021, ENTITLED: "A LOCAL LAW ESTABLISHING REVISED RESIDENCY REQUIREMENTS FOR COUNTY EMPLOYMENT"

Answering a guestion from Ms. Ryan, Mr. Garnar stated that his Local Law will allow the County a broader area from which to recruit good candidates and fill positions where there may be difficulty in hiring individuals. Ms. Ryan further expressed concerns with eliminating the residency requirement for many County positions and would rather take more time and think this proposal through. Mr. Whalen expressed similar concerns to Ms. Ryan and thinks the County needs to work on greater recruitment efforts and that this Local Law would make wholesale changes and urged caution in approving this.

Answering a question from Mrs. Beebe, Mr. Behan stated that Broome County has a tuition reimbursement program for employees to further their education and also mentioned civil service promotional exams.

Mrs. Myers expressed her understanding how difficult it can be to fill open positions and the need to recruit from a greater area. She further stated that she doesn't believe that more time to consider this proposal would change anything. Carried. Ayes-4, Nays-1 (Ryan)
