#5 RESOLUTION CONFIRMING APPOINTMENT TO MEMBERSHIP ON THE BROOME COUNTY COMMUNITY SERVICES BOARD

Mr. Weslar made a motion to amend Resolution #5, seconded by Ms. O'Brien, to include language to waive in-county residency for Broome County Community Services Board Member Pearl Reed-Klein, who lives outside of Broome County. The amendment also adds "Catholic Charities" under Ms. Reed-Klein's name to reflect the 232 Main Street, Binghamton, NY 13901 address that is listed on the resolution.

In response to a question from Ms. O'Brien, Ms. Williams stated that this is a new program for the Department of Social Services and the funding will be used to obtain computer equipment and to hire and train staff. Ms. Burns stated there was a decrease in referrals due to the suspension and closing of day programs for clients at the start of the COVID-19 pandemic.
