#47 RESOLUTION AUTHORIZING PERSONNEL CHANGE REQUESTS FOR THE OFFICE OF THE BROOME COUNTY SHERIFF Answering a question from Mr. Whalen, Mr. Janis stated that the Corrections Captain makes less than some of the Corrections Lieutenants that he supervises currently. He also stated that the Sheriff's Office has wanted to increase this position for a while and when this individual retires, they believe it will be difficult to recruit for the position with a lower salary.

Answering a question from Mr. Weslar, Mr. Janis stated that the Fiscal Manager currently has more responsibilities than before, he also supervises more staff than he did a year or so ago. They are looking to have this position upgraded to Fiscal Services Administrator.

Answering a question from Mrs. Beebe, Mr. Janis stated that they requested the raises be retroactive for the Corrections Captain as they've been trying to upgrade the position for over a year, and the Fiscal Services Administrator as retroactive due to when the individual took and passed the Civil Service exam for the position.

Mr. Weslar requested that the Sheriff's Office provide the total for both salary increases combined, and due to the vacancies in the Corrections Division, what the current total in salary savings there is available to fund the increases, which Mr. Janis stated they would supply that info to the Legislative Clerk's Office.

Mr. Whalen made a motion, seconded by Mr. Weslar to recommend to the Personnel Committee, who is one of the co-prime committees, to amend the Resolution to remove the retroactivity of the pay raises and grade changes.
