# RESOLUTION AUTHORIZING HOME RULE REQUEST TO AUTHORIZE THE COUNTY OF BROOME TO IMPOSE AN ADDITIONAL ONE PERCENT SALES AND COMPENSATING USE TAX

WHEREAS, by Resolution No. 373 of 1993, this Legislature requested the New York State Legislature to enact State Legislation authorizing the County of Broome to impose an additional one percent of sales and compensating use taxes, and

WHEREAS, Assembly Bill A9231-B and Senate Bill S6490-B have been introduced into the New York State Assembly and Senate respectively to amend the tax law, in relation to authorizing the County of Broome to impose an additional one percent of sales and compensating use taxes, and

WHEREAS, pursuant to Article IX of the Constitution of the State of New York, it is necessary for this Legislature to enact a Home Rule Request for the passage of said legislation, now, therefore, be it

RESOLVED, that this County Legislature hereby urges and approves the adoption and passage of said Assembly Bill A9231-B and Senate Bill S6490-B entitled "An Act to Amend the Tax Law in Relation to Authorizing the County of Broome to Impose an Additional One Percent of Sales and Compensating Use Taxes", and hereby declares that a necessity exists for the passage of such bill and that the local legislative body of the County of Broome does not have the power to enact such legislation by local law, and be it

FURTHER RESOLVED, that a Home Rule Request be submitted to the Senate and Assembly of the New York State Legislature indicating that the necessity exists for the enactment of said legislation.
