Child Endangerment, Unlawful Imprisonment, Resisting Arrest and Other Charges from a Domestic Incident in the Town of Fenton

(TOWN OF FENTON) A Port Crane man was arrested on Child Endangerment, Unlawful Imprisonment, Resisting Arrest and other charges after a physical domestic incident in the Town of Fenton.

Near midnight on October 13, 2023, Broome County Sheriff's Deputies responded to a report of a domestic dispute on Weber Road in the Town of Fenton. Upon arrival, patrols found Adam McKrell, age 33 of Port Crane, in the front yard of a residence acting irate and yelling at his girlfriend before aggressively yelling at patrols as well. The female victim was attempting to gather her items and leave in her vehicle while McKrell continued to physically prevent her from doing so.

Deputies attempted to mediate the situation, however, McKrell refused to calm down and refused to comply, trying to physically push his way past deputies to confront the female. McKrell resisted arrest and after a NY State Trooper at the scene effectively deployed a Taser on him, he was taken into custody without injury.

The investigation determined that earlier in the evening, McKrell had pushed the female victim to the floor and struck her multiple times in the presence of three children living at the residence. When she attempted to leave, McKrell repeatedly prevented her.

Adam D. McKrell was arrested and charged with the following:

- Three Counts of Endangering the Welfare of a Child (knowingly acting in a manner likely to be injurious to the physical, mental, or moral welfare of a child aged 16 or younger), a Class A Misdemeanor
- Unlawful Imprisonment in the 2nd Degree, a Class A Misdemeanor
- Resisting Arrest, a Class A Misdemeanor
- Obstructing Governmental Administration in the 2nd Degree, a Class A Misdemeanor

McKrell was arraigned at central arraignment and released. He is due to appear in the Town of Fenton Court at a later date to answer for his charges.

The female victim requested an Order of Protection.
