WARRANT UPDATE: Wanted Broome County Fugitives Arrested in Owego and Orlando

Two individuals wanted by the Broome County Sheriff's Office were taken into custody today in Owego and Florida.

Veronica Mitchell, age 34 of Endicott, was located by the Broome County Sheriff's Office Warrants Division, with the assistance of the Binghamton Police Department Warrants Division, New York State Parole, and the New York State Police Violent Felony Warrant Division, at a residence on Day Hollow Road in the Town of Owego.

Mitchell was found at the residence hiding in a storage room, arrested and transported to the Broome County Correctional Facility.

Mitchell was wanted regarding felony drug and weapon possession charges and was additionally charged with Resisting Arrest and Obstructing Governmental Administration in the 2nd Degree, Class A Misdemeanors and will be arraigned in the Town of Owego Court at a later date.

Souley Pertilla-Camara, age 23 of Binghamton, NY, Broome County's Number 3 Most Wanted, was arrested today in Orlando, Florida.

Pertilla-Camara was being sought after by the Binghamton City Police Department for the shooting of Lamont Weaver on June 17, 2023, where Weaver sustained a gunshot wound to the abdomen and survived. Also wanted on an outstanding warrant for Criminal Possession of a Weapon in the 2nd Degree, Pertilla-Camara was quickly added to the United States Marshals Regional Fugitive Task Force open cases and an investigation began into his whereabouts.

The Broome County Sheriff's Office Warrants Division was able to determine that Pertilla-

Camara had fled New York State and tracked him down to Orlando, Florida. Information was then sent to the Marshals Regional Fugitive Task Force in Orlando, Florida, where they were able to locate him and arrest him this morning.
