## Free Sheriff's Summer Camp Applications Due April 1st

Camp provides free admission, food, lodging, travel, and activities for local families

(TOWN OF DICKINSON, NY) Applications are open for kids age 9-12 to attend the 2024 NYS Sheriff's Summer Camp in June.

Each year, children from across the state travel to Keuka Lake in Penn Yan, NY to attend the Sheriff's Summer Camp free of charge. The program is fully funded by the New York State Sheriff's Institute and is designed to provide the full camp experience to children between the ages of 9 and 12 who, because of economic reasons, would not have the opportunity to attend a summer camp or enjoy a summer vacation.

County Sheriffs are given a certain number of camper slots for children to attend each summer. There is no cost for families. Food, lodging, travel, and activities are all free and paid for by donations. Youth are provided with athletic, musical, aquatic, recreational, and creative pursuits throughout their weekly camp session.

This year, Sheriff Fred Akshar has placed no firm cap on the number of slots available to local campers.

"This is a unique opportunity for families of Broome County and we want to make sure they are able to take full advantage of it," said Sheriff Fred Akshar. "Not every family has summer camp or a summer vacation in their budget, and the Sheriff's Summer Camp is there to help those families and their children still have the chance to make lifelong memories and unforgettable experiences at a crucial and formative time in their lives. If you or someone you know is a parent facing financial challenges this year, we're urging you to please consider taking part in this outstanding program."

Sheriff Deputies and Corrections Officers from across the state volunteer their time each year and are essential to the camp's daily curriculum. Four to six deputies are in residence during each of the six 1-week sessions, with other deputies visiting daily, providing demonstrations on K9 Units, Helicopters, Motorcycles, Horses, Marine Units and more as well as a presentation regarding illicit drugs and alcohol use.

Corrections Sgt. Celina Sunderlin has volunteered at the Sheriff's camp for 7 years.

"I've volunteered at the camp for 7 years and I can't wait to go back," said Corrections Sgt. Celina Sunderlin. "From the first day the kids arrive at camp until the day they leave, just watching the kids grow and learn, make new friends and have fun, it's an amazing experience for us and for them. I would recommend it to any family. It's unforgettable."

Initial Applications (Page 1 of the Application Packet) are due on April 1<sup>st</sup>, with the primary criteria being economically challenged children and children who can benefit from the positive interaction with deputy sheriffs. All four pages of the Camp Application, which includes health/medical portions that must be completed by a doctor must be submitted by May 1<sup>st</sup>.

Originally established as the YMCA Camp, "Camp Iroquois," nearly 100 years ago, New York State Sheriffs have been proud to offer such a fantastic camp experience for disadvantaged youth from all over New York State since 1986. It's a place where energy, enthusiasm, caring, and dedication create an atmosphere where campers feel included, supported and nurtured.
