## BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE March 7, 2024 Weekly Arrest Blotter

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Adrian M. Atutis, age 33 of Binghamton, NY, was charged Resisting Arrest, a Class A Misdemeanor, Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor and two separate charges of Harassment in the 2<sup>nd</sup> Degree (Physical Contact), Violations following a domestic incident in the Town of Chenango.

James F. Bell, Jr., age 47 of Conklin, NY, was charged with two Counts of Criminal Possession of a Controlled Substance the 3rd Degree, Class B Felonies and Criminal Use of Drug Paraphernalia in the 2nd Degree, a Class A Misdemeanor, following a traffic stop in the City of Binghamton. While in custody, Bell was found to have concealed on his person a plastic bag of a crystal-like substance that field tested positive for Methamphetamine. Bell was additionally charged with Tampering with Physical Evidence, a Class E Felony.

Kevin J. Bush, age 62 of Windsor, NY, was charged with Criminal Contempt in the 1<sup>st</sup> Degree (Physical Contact), a Class E Felony and Harassment in the 2<sup>nd</sup> Degree, a Violation, following a domestic incident in the Town of Windsor. After being released on an appearance ticket, Bush returned to residence later that day, violating the court order of protection again. Bush was then charged with and was Criminal Contempt in the 2<sup>nd</sup> Degree, a Class A Misdemeanor.

Kenneth L. Carman, age 32 of Lisle, NY, was charged with Sexual Misconduct and Animal Cruelty following an investigation into animal sexual abuse in the Town of Lisle.

Cody F. Carlson, age 40 of Deposit, NY, was processed on two separate charges of Petit Larceny, a Class A Misdemeanor following an investigation into stolen cans and bottles from two locations in the Village of Deposit.

Harris, age 39 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, and three separate charges of Criminal Use of Drug Paraphernalia in the 2<sup>nd</sup> Degree, Class A Misdemeanors, following an investigation into a narcotics complaint in the Town of Chenango.

Martin L. Matias, Jr., age 38 of Port Crane, NY, was charged with Criminal Possession of Narcotics with Intent to Sell in the 3<sup>rd</sup> Degree, a Class B Felony, Criminal Possession of Narcotics in the 4<sup>th</sup> Degree, a Class C Felony, and Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, following a warrant execution in the Town of Colesville.

Veronica A. Mitchell, age 34 of Endicott, NY, was charged with Resisting Arrest and Obstructing Governmental Administration in the 2nd Degree, Class A Misdemeanors, following a warrant execution in the Town of Owego.

Yashua D. Morrison, age 29 of Johnson City, NY, was charged with Criminal Possession of Cannabis (More than 16 oz) in the 3<sup>rd</sup> Degree, a Class A Misdemeanor, following a traffic stop in the Town of Union.

Craig P. Spencer, age 55 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, following a traffic stop in the Town of Union.

Bridget M. Wilmarth, age 27 and Rachel Cochran, age 25 of Endicott, NY, were each charged with Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, Class A Misdemeanors, following a traffic stop in the Town of Union.
