## **BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE**

Man Charged with Aggravated DWI after Motor Vehicle Accident in Town of Union

(TOWN of UNION, NY) A motor vehicle accident on Norton Ave. in the Town of Union led to an Endicott man being charged with aggravated driving while intoxicated (DWI) and other charges.

On June 15, 2023 at 3:40pm, a Broome County Sheriff's Office patrol responded to motor vehicle accident at the intersection of Norton Ave. and Watson Blvd. in the Town of Union.

Upon arrival, the responding Sergeant discovered one of the drivers, Andrew L. Tredo, age 37 of Endicott, asleep in the driver's seat of a parked 2008 Subaru Legacy. The investigation and statements by witnesses showed that shortly after rear-ending a vehicle stopped at the intersection on Norton Ave., Tredo drove his vehicle to a nearby parking lot and passed out.

Responding patrols were able to wake Tredo, who displayed slurred speech, significant balance issues, confusion and several other signs leading law enforcement to suspect intoxication. Tredo admitted to consuming alcohol before the accident and multiple open containers of alcohol were found in the rear seats and front of the vehicle.

The responding deputy began performing Standardized Field Sobriety Testing on Tredo, but Tredo advised the deputy he would fail and refused to complete the testing. Tredo provided a breath sample to determine his BAC, which was measured to be 0.39, just under 5x the legal limit.

Following the investigation, Andrew L. Tredo was arrested and charged with the following:

- Aggravated Driving While Intoxicated with a BAC of over 0.18, a Misdemeanor
- Driving While Intoxicated with a BAC of over .08, a Misdemeanor
- Three counts of Drinking Alcohol in a Motor Vehicle on the Highway, a Violation
- Failure to Obey a Traffic Device, a Violation
- Failure to Stop at a Stop Sign, a Violation

• Operating a Motor Vehicle without an Inspection Certificate, a Violation.
