### **June 21, 2024 Weekly Arrest Blotter**

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

James A. Baker., Jr., age 52 of Binghamton, NY, was charged with Conspiracy in the 5<sup>th</sup> Degree and Hindering Prosecution in the 3<sup>rd</sup> Degree, Class A Misdemeanors, following a traffic stop in the City of Binghamton.

John A. Blackington, Sr., age 65 of Halstead, PA, was charged with Criminal Contempt in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, following an investigation into a violation of an order of protection in the Town of Kirkwood.

Joshua T. Cottrill, age 33, was charged with Resisting Arrest, Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree and Escape in the 3<sup>rd</sup> Degree, Class A Misdemeanors, after attempting to flee custody following a sentencing for a separate charge at the Town of Chenango Court.

Kale M. Dean, age 26 of Whitney Point, NY, was charged with Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree and Resisting Arrest, Class A Misdemeanors, following an investigation into an unattended vehicle on a public roadway in the Town of Lisle, NY.

Theresa M. Decker, age 43 of Johnson City, NY, was charged with Bail Jumping in the 3<sup>rd</sup> Degree, a Class A Misdemeanor, following a warrant execution in the Village of Johnson City.

Daniel J. Dermody, age 33 of Vestal, NY, was charged with Aggravated Harassment in the 2<sup>nd</sup> Degree, a Class A Misdemeanor following an investigation into reported harassment in the Town of Windsor.

Timothy B. Doty, age 51 of Binghamton, NY, was charged with Criminal Contempt in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, following a warrant execution in the Town of Dickinson.

Benjamin C. Reynolds, age 42 of Binghamton, NY, was charged with Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree and Resisting Arrest, Class A Misdemeanors, following the execution of multiple warrants in the City of Binghamton.

Lance W. Rosler, age 54, was charged with Reckless Endangerment in the 1<sup>st</sup> Degree, a Class D Felony, three counts of Unlawful Fleeing a Police Officer in the 3<sup>rd</sup> Degree, Class A Misdemeanors, Resisting Arrest, a Class A Misdemeanor, Hindering Prosecution in the 3<sup>rd</sup> Degree, a Class A Misdemeanor, Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, Obstruction of Government Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, Conspiracy in the 6<sup>th</sup> Degree, a Class B Misdemeanor, and over 50 traffic violations through three jurisdictions following a traffic stop in the City of Binghamton.
