## BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE

### June 5, 2024 Weekly Arrest Blotter

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Emma R. Brown, age 22 of Binghamton, NY, was charged with Burglary in the 3<sup>rd</sup> Degree (Illegal Entry with Intent to Commit a Crime), a Class D Felony, Criminal Mischief in the 4<sup>th</sup> Degree (Disabling Equipment to Prevent Requesting Emergency Services), a Class A Misdemeanor, and Harassment in the 2<sup>nd</sup> Degree (Physical Contact) a Violation, following an investigation into a domestic incident in the Town of Union.

Ronald L. Camber, age 50 of Binghamton, NY, was charged with Obstructing Governmental Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, and numerous traffic violations following a traffic stop in the City of Binghamton.

Joseph C. Chinchilla, age 29, was charged with Reckless Endangerment in the 1<sup>st</sup> Degree, a Class D Felony and Unlawful Fleeing a Police Officer in a Motor Vehicle in the 3<sup>rd</sup> Degree, a Class A Misdemeanor following a search warrant execution in the Town of Chenango.

Jason T. Fletcher, age 49 of Port Crane, NY, was charged with Menacing in the 2<sup>nd</sup> Degree following an investigation of a domestic incident in the Town of Colesville.

Evan A. Kowal, age 41 of Rochester, NY, was charged with Petit Larceny, a Class A Misdemeanor, following a larceny investigation in the Town of Chenango.

Andrew D. Link, age 34, was charged with Criminal Contempt in the 1<sup>st</sup> Degree (Violating an Order of Protection with a Prior Conviction in the Past 5 Years), a Class E Felony, following an investigation into a domestic incident in the Town of Chenango.

Paige S. Merrick, age 20 of Gillette, PA, was charged with Bail Jumping in the 1<sup>st</sup> Degree, a Class D Felony, after failing to appear in Broome County Court to answer for previous charges.

Cody J. Nord, age 36 of Endicott, NY, was charged with Aggravated Family Offense, a Class E Felony and Criminal Contempt in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, following an investigation into an order of protection violation in the Town of Union.

Dominique Pettiford, age 31 of Binghamton, NY, was charged with Grand Larceny in the 3<sup>rd</sup> Degree (Property Value Exceeds \$3,000), a Class D Felony and Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree (Methamphetamine with Intent to Sell), a Class B Felony, following a larceny investigation in the Town of Kirkwood.

Trae T. Salisbury, age 29 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree and Unlawful Fleeing a Police Officer in a Motor Vehicle in the 3<sup>rd</sup> Degree, Class A Misdemeanors, following a traffic stop in the City of Binghamton.

Gerardo A. Valdes, Jr., age 18 of Binghamton, NY was charged with Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree, a Class E Felony, following a traffic stop in the City of Binghamton.

Jerran D. Willis, age 33 of Binghamton, NY, was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the 1<sup>st</sup> Degree, a Class E Felony and multiple violations following a traffic stop in the Town of Dickinson. Willis was found to have been driving with a total of 30 license suspensions.
