The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Steven W. Skellett, age 73 of Chenango Forks, NY, was charged with Stalking in the 4<sup>th</sup> Degree, a Class B Misdemeanor, following an investigation into his multiple attempts to enter the home of a resident in the Town of Union.

Michael W. Taylor, age 66 of Binghamton, NY, was charged with Criminal Trespass, a Violation, following an investigation into trespassing in the Town of Union.
