#### **Patrol Division**







The Broome County Sheriff's Office Patrol Division is the primary Law Enforcement agency for 49.5 % of the residents in Broome County. The Patrol Division serves the residents of Broome County as they attend school, go to work and shop outside the city and village limits within the county. The Patrol Division also provides law enforcement services to the other five municipal police agencies within the county and answers calls for service in their respective jurisdiction when the need arises. The Patrol Division enforces the laws of the State of New York and does so while patrolling 1008 miles of State Highways, 350 miles of county roadways and 927 miles of town roads on a twenty four hour a day, seven day a week basis. The Patrol Division is also equipped to handle specialized calls for service by deploying the Marine Unit, the Motor Unit and the SWAT Special Weapons and Tactic Team when the need arises.


The Broome County Sheriff's Patrol Division is staffed with the following personnel:

The Broome County Sheriff's Office Patrol Division maintains a fleet of 19 patrol vehicles to include 10-Chevrolet Tahoe's and 9-Ford Crown Victoria's.


During the year 2011 the Patrol Division handled 20,643 calls for service which was an increase from the 2010 total of 20,168. An additional 11,920 quick call complaints which are generated by the deputies while they were working in their respective patrol zones. A Deputy will generate a "quick call" when he or she exits their patrol vehicle for a self-initiated investigation or when he or she conducts a vehicle stop. A quick call may or may not generate an actual incident or a call for service. The following pages set forth a breakdown of these calls for service and the arrests made by the deputies.

# Calls for Service-By Shift









During the time spent ridding the streets of intoxicated and impaired drivers members of the Sheriff's Office issued 136 Vehicle and Traffic citations including 18 relating to DWI arrests. It is and will continue to be the commitment of every member of the Sheriff's Office to keep the roadways in Broome County absent of drunk drivers.

# Fatal Motor Vehicle Accident Town of Fenton





Members of the Broome County Sheriff's Office investigated a one car fatal motor vehicle accident on Interstate 88 in the Town of Fenton. As a result of this accident three people were killed after the vehicle that they were passengers in became submerged in the swollen Chenango River. The operator of the vehicle was indicted on DWI and manslaughter related charges. Alcohol and driver inattention were contributing factors to the motor vehicle accident.

## Fatal Motor Vehicle Accident Town of Union

# Man Impersonates a Red Cross Employee Town of Union

During the month of September, members of the Broome County Sheriff's Office conducted an investigation into a male who was posing as a volunteer with the Red Cross as well as a volunteer firefighter. Sean A. Rogler 28 years old was spending time at a local shelter that had been set up for flood victims. During this time, Rogler while acting in this capacity did summons ambulances for people with minor medical conditions and interacted with other people who were staying in the shelter. No one was hurt, injured or victimized as a result of Rogler's behavior. Rogler was charged with several misdemeanor crimes and remanded to the Broome County Sheriff's Office Correctional Facility.

# Broome County Sheriff's Office Motorcycle Unit Summary

The Broome County Sheriff's Motorcycle Unit began the 2011 riding season with a total of six full-time riders; Deputies Alan Bennett, Daniel Wilcox and Sam Davis on the day shift, Deputies Willard Andres and Ben Harting on the afternoon shift, and Deputy Rob Fish on the night shift. Due to promotions and assignment changes, Deputies Andres, Harting and Davis have been changed to a part time status, and Deputy Michael Kelly has returned as a full-time rider. The Motor Unit can also utilize Sgt. Scott McDonald, Sgt. Shaun Carnevale, Deputy Julie Fleming, Detective James Broderick, Detective Edward Sakowsky and Detective John Harder on a part-time basis as Unit back-up or coverage for events and details.

The Motor Unit is equipped with two Harley Davidson Police Motorcycles. One is a 2000 model FLHPI 88 Police Road King, designated as MC1. The second is a 2007 FLHPI 95 Police Road King designated as MC2. Both MC1 and MC2 are in serviceable condition at this time. Additionally, we can transport one or both units in our 9x12 enclosed transport trailer. MC1 is equipped with a portable STALKER handheld radar unit that can be used for stationary speed enforcement. MC2 is equipped with a hard-mounted STALKER DUAL radar unit that can be utilized for both stationary and moving

radar with both a front and rear antennae.

Due to poor weather and the flooding in September 2011, the Motor Unit had a short patrol season this year, beginning on May 30th continuing through early September. The Motorcycle Unit was deployed primarily for parades and special details during the 2011 season. A review of the summer's assigned shifts revealed that the motor unit was deployed only sporadically for routine Uniformed Patrol duties and Traffic Enforcement. Even with a total of only 5 deployments, the motor unit racked up a total of 20 Uniformed Traffic Tickets, and generated numerous other tickets for regular patrol units.

The Motor Unit's utilization for 2011 was primarily for parade and special details, as well as Community Oriented Policing functions. Despite shortages in manpower, the Motor Unit was still able to increase our participation in these types of events for the sixth consecutive year, thereby increasing our exposure to the public. ## Marine Patrol 2011 Summary





The Marine Patrol is comprised of four Sergeants and seven Deputies who are responsible for the enforcement of boating safety regulations, as well as conducting search, rescue, and recovery operations. The officers are also responsible for the verification and assignment of Hull Identification Number for registration purposes. This unit utilizes three boats to patrol the waterways of Broome County, a 14 foot Grumman aluminum boat powered by a 25 horse power Evinrude motor, a 14 foot Quicksilver inflatable boat powered by a 25 horse power Mercury motor, and a 16 foot Rivercraft air boat. The Marine Patrol is also equipped with underwater video camera and a Global Positioning System. The following is a list of events that the Sheriff's Marine Patrol was involved in throughout 2011.

On July 2, 2011 the Marine Patrol was deployed to Dorchester Park in Whitney Point to provide safety and security for the Broome County Triathlon.

On July 28 and August 25 of 2011 the Marine Patrol unit conducted training maneuvers on the Chenango River with the New York State Forest Rangers.

On April 28 2011 the Marine Patrol was dispatched to 3920 Rt. 26 in the Town of Nanticoke and performed a Rescue operation during a flood event.


On May 20 through June 5 of 2011 the Marine Patrol was utilized for search operations after a triple fatal motor vehicle accident on Rt. 88 in which a vehicle drove into the Chenango River. Search operations resulted in the recovery of one victim.

Beginning on September 6 of 2011 the region experienced severe and prolonged flooding. The Marine Patrol was used for numerous search and rescue operations over the course of nine days.

On September 28 of 2011 the Marine Unit assisted the Binghamton Police Department in searching the Susquehanna River for a person that jumped from the Court Street Bridge.

## **DETECTIVE DIVISION**

The Broome County Sheriff's Detective Division is comprised of two Detective Sergeants who supervise two units. The General Investigations Sergeant supervises four General Investigations Detectives, one Juvenile Detective and two Deputy Sheriff's assigned to the Warrant Division. The Special Investigations Sergeant supervises five SIU Detectives who are also assigned to the Broome County Special Investigations Task Force. Members assigned to the Division maintain the sex offender registry, DNA gathering registry and evidence control. Members are assigned to the Southern Tier Child Predator Task Force, Operation Impact, Child Advocacy Case Review Committee, Gang Task Force Meetings, Counter Terrorism Zone Meetings, Bank Security Meetings and Retail Security Meetings. Members also provide presentations to various government and private groups.









#### **WARRANT UNIT**

The Warrant Control Unit of the Broome County Sheriff's Office is comprised of two, (2) Deputy Sheriffs under the direction of the Detectives Sergeant assigned to General Investigations. The unit is responsible for the management of warrants issued to the Broome County Sheriff's Office by Broome County Supreme Court, Broome County Family Court and local Justice Courts throughout Broome County. The deputies assigned to the unit insure entry of each warrant received into the Broome County Public Safety System and NYSPIN (New York State Police Information System) to readily identify wanted persons who may be encountered by Police Officers locally or nationwide.

The Broome County Sheriff's Office continues to work with New York/New Jersey Regional Fugitive Task Force. Four Sheriff's Office members are sworn United States Deputy Marshals. They work along with members of the Marshal's Service, Binghamton Police Department and New York State Police. The task force increased the resources available to better track fugitives not only in New York State but across the country.

The Warrant Control Unit distributes the warrants issued by Local Criminal Courts to Highway Patrol Deputies for execution and monitors the action taken. The Unit is responsible for the execution of all Broome County Court and Broome County Family Court warrants. In addition to New York State, the Unit is responsible for the extradition of wanted subjects that are located outside New York State.





On October 30, 2010 the Broome County Sheriff's Office was notified that a body had been discovered on Wilson Hill Road in the Town of Chenango. The body was identified as Daniel Martinez 27 years of age of the Bronx New York. It was quickly determined Martinez was the victim of a homicide. Within a short time into the investigation two suspects were identified and subsequently taken into custody. Arrested for 2<sup>nd</sup> degree murder were Joseph Ross-Jones 25 years of age and Daniel Doherty 21 years of age both of Binghamton, New York.

#### **ASSAULT CASE**

On October 8, 2011 the Broome County Sheriff's Office was notified of a person on fire at a residence at 71A Carmichael Road Town of Chenango. Upon arrival deputies determined that the victim a 35 year old male had rubbing alcohol poured on his clothing and then a subject ignited the rubbing alcohol. Detectives identified Kelly F Cordner 41 years of age and Janice K Peterson 44 years of age both of Binghamton as the subjects involved in the assault. Both were charged with Assault in the 1<sup>st</sup> degree a felony. The victim received second and third degree burns to approximately 33% of his body and is still recovering from the injuries.

#### **FUGITIVE ARREST**

The Broome County Sheriffs Office and the United States Marshals Fugitive Task Force arrested Christopher A Burchell 44 years of age of Endicott. He had been a fugitive wanted for Grand Larceny and Scheme to Defraud both felonies. Burchell is accused by sheriff's detectives of defrauding elderly people throughout Broome and Tioga Counties stealing thousands of dollars from numerous victims.

Burchell was located by task force officers in the early morning hours of November 9, 2011 upon being approached he fled in a vehicle. Burchell crashed into a fence at Ely Park Apartments then fled on foot. Task force officers caught Burchell in a wooded area. Burchell was additionally charged with criminal mischief, reckless endangerment and resisting arrest all misdemeanors in relation to attempting to evade arrest.

#### **SEX OFFENDERS ARRESTED**

In the early morning hours of July 30, 2011 an attempted forcible rape was reported to the Broome County Sheriff's Office. The attempted rape occurred on a flood wall in the West Corners area of the Town of Union. During the course of the investigation a level 3 sex offender living in the area was identified as the suspect. John M Desmond 22 years of age was arrested and charged with attempted rape 1<sup>st</sup> degree and criminal sexual act 1<sup>st</sup> degree both felonies. Desmond had a previous conviction in 2007 for sexual misconduct which placed him on the New York State Sex Offender Registry.

On October 4, 2011 the Broome County Sheriff's Office received a report of a sexual assault of a child that occurred in the Town of Fenton. It was reported that a 7 year old child was sexually and physically assaulted while under the care of a level 2 sex offender. Justin M Hoover was subsequently arrested and charged with Assault in the 2<sup>nd</sup> degree and criminal sexual act 1<sup>st</sup> degree, both felonies. Hoover had a previous conviction in 2011 for rape in the second degree which placed him on the New York State Sex Offender Registry.

# BROOME COUNTY SPECIAL INVESTIGATIONS UNIT TASK FORCE



#### Mission

The Broome County Special Investigations Unit Task Force is a multi-jurisdictional task force primarily committed to the suppression of illegal and illicit drugs within Broome County. The Task Force actively pursues those individuals or groups who manufacture, distribute or sell illegal drugs within the jurisdictional boundaries of Broome County. In addition, the Task Force focuses on enforcing laws related to illegal firearms, prostitution and Alcoholic Beverage Control Laws of the State of New York.

The Broome County Special Investigations Unit Task Force is comprised of sworn law enforcement officers from the Broome County Sheriff's Office, City of Binghamton Police Department, and Village of Johnson City Police Department. Currently the Broome County Sheriff's Office has a Detective Sergeant and five Detectives assigned to the Task Force; City of Binghamton Police Department has a Sergeant and five Investigators assigned to the Task Force; and the Village of Johnson City Police Department has an Investigator assigned to the Task Force. The total number of members assigned to the Task Force is 13. These three separate agencies not only work together as the Task Force, they also work closely with other local, state and federal law enforcement agencies. Thus, the mission of the Task Force is accomplished through the

combined and coordinated enforcement efforts among the various law enforcement agencies working within or directly with the Task Force.

The Task Force accomplishes its mission by utilizing the following investigative techniques:

- ➤ Surveillance
- ➤ Confidential Sources
- > Search Warrants
- > Eavesdropping Warrants
- ➤ Undercover Operations

#### **Analysis of 2011 Goals**

At the beginning of 2011, members of the Task Force had established three goals that they wished to achieve during the year. One goal was to continue to bolster our relationship with agencies outside of the Task Force in an effort to most effectively and efficiently achieve each agency's goals while supporting their individual mission statement.

In order for a law enforcement agency to carry out narcotic related investigations, such as undercover operations, surveillances, wiretaps, and the execution of Search Warrants, the agency needs to allocate sufficient numbers of experienced personnel and resources to ensure that investigations are carried out safely and successfully. Since the creation of the Task Force, individually assigned agencies have continued to accept the concept of a task force. By bringing experienced law enforcement officers together, combining resources, and learning to work as one, the Task Force has been successful in accomplishing its mission. Outside law enforcement agencies have taken notice of that success and some have expressed a desire to work more closely with the Task Force. One way this is being accomplished is by encouraging outside agencies to attend regularly held weekly Task Force meetings. Historically, these meetings were held as a forum for assigned Task Force members to discuss case progression and share developed intelligence. This year, the Task Force has had representatives from outside agencies attend those weekly meetings (i.e. Endicott Police Department, New York State Police Special Investigations Unit, U.S. Marshals Fugitive Task Force and the Federal Bureau of Investigations). As a result, we have been able to build closer relationships with those outside agencies creating a more cooperative crime fighting environment throughout Broome County.

An example of this new level of cooperation in narcotics enforcement was made clear with the arrest of Willie McLeon. McLeon was believed to be trafficking heroin in the Village of Endicott and throughout Broome County. In addition, Task Force members developed information that McLeon was in possession of an AK-47 style assault rifle and was also a member of the Bloods street gang. The Village of Endicott Police Department worked with members of the Broome County Task Force in developing reliable information and intelligence on McLeon. This cooperation eventually led to the

development of sufficient probable cause that allowed a Task Force member to apply for a Search Warrant to search McLeon's residence, vehicle and person. During the course of the investigation, the Search Warrants were executed and the searches yielded a quantity of heroin, U.S. Currency and a loaded Romarm/Cugir 7.62 mm Automatic Rifle (AK-47). McLeon was charged with two counts of Criminal Sale of a Controlled Substance in the Third Degree, Criminal Possession of a Controlled Substance in the Third Degree, and Criminal Possession of a Weapon in the Second Degree. This investigation is just one of many instances of how the Task Force cooperates with outside agencies to further investigations that lead to the arrest of individuals trafficking illegal drugs in the Broome County area.

The Broome County area has seen an increase in the number of individuals identifying themselves as members of a street gang such as Bloods, Crips or Latin Kings. A second goal of the Task Force was to continue targeting those individuals who associate themselves with a street gang and engage in illegal activity. The Task Force has had past success in investigating gang activity in the Broome County area. Due to this success, the United States Marshal Fugitive Task Force approved funding that was provided to the Broome County Sheriff Office and City of Binghamton Police Department. This funding was used to pay for overtime of specific members who worked on investigations involving individuals who engage in gang related activity. The funding helped in furthering investigations of gang members operating in the Broome County area and has resulted in the arrest of 33 gang members. The arrests of these individuals further assisted in the successful solving of other violent crimes that occurred in the City of Binghamton.

An example of this was the continual gang activity associated with Victoria's Restaurant, an establishment located on Susquehanna Street in the City of Binghamton. Over the past several months, this establishment was the scene of numerous violent crimes that involved gang members. The establishment routinely held after hour parties in which many of the patrons were known gang members. One specific crime that occurred at this establishment was the robbery and assault of a patron. The victim was robbed of personal property and shot during the course of the robbery. Initially, City Investigators received little cooperation from the victim and witnesses. Eventually, Investigators were able to learn that a Blood gang member, identified as Derek Heyliger, was responsible for robbing and shooting the victim.

Task Force members immediately started assisting members of the City of Binghamton Detective Division. Parallel investigations of individuals present at the time of the incident were initiated. Task Force members built narcotic cases against these individuals that eventually led them to cooperate with the police and prosecutors. The information developed from those arrests was invaluable in developing a case against Derek Heyliger. Heyliger was eventually indicted and convicted in Broome County Court for robbing and shooting the victim.

The third goal of the Task Force was upgrading aging undercover monitoring systems utilized by members during undercover operations. It should be noted that the very

nature of covert surveillance and monitoring dictates that systems used by law enforcement be kept confidential thus, this report will only provide generalities and not specific descriptions of monitoring systems. Currently, the Task Force uses an antiquated system that consists of RF body wires to monitor officers when conducting undercover operations. As this system continues to age it is becoming more unreliable and difficult to safely monitor officers during undercover operations. The Task Force began looking to update the old technology by moving into the digital age. The clear advantage of updating to digital technology is the low probability of detection, almost no range restrictions, crystal clear audio, capturing of conversations for evidentiary purposes, and GPS tracking. There are numerous companies that provide different systems. Ability and pricing varies among the different systems. The common theme is that the technology needed is expensive and requires payment of monthly fees. The City of Binghamton pruchased a new technology system. The Task Force experimented with different systems and one was chosen to be purchased. The new system will be up and running early in 2012.

#### 2012 Goals for Task Force

- ➤ The Task Force will continue efforts to suppress gang activity in neighborhoods. Individuals who practice gang activity by engaging in trafficking of illegal drugs and violent crimes will be identified and targeted.
- The Task Force will develop a protocol that encourages an increase in the sharing of gathered intelligence with other units (i.e. Patrol Units, Detective Divisions, and Community Response Teams) and outside law enforcement agencies. By sharing this intelligence it is believed that it will aid those units and outside law enforcement agencies with accomplishing their individual missions.
- ➤ The Task Force will work to upgrade its existing vehicle surveillance platform to the Digital and Internet Video Age.









# Person Arrested After a Search of Residence Yields Handguns and Cocaine

In January 2011, members of the Task Force executed a Search Warrant at a residence located in the City of Binghamton. A search of the residence yielded approximately 85 grams of cocaine, U.S. Currency, .32 caliber handgun and a .25 caliber handgun. The target of the investigation was charged with felony narcotic and weapon charges.

### Joint Investigation Results in Raid on Three Area Asian Massage Parlors

Working off a tip that Asian females were using area massage parlors as a front for prostitution, the Task Force was able to take the lead in an investigation that eventually resulted in the raid of three area Asian Massage Parlors. Members of the Broome County Task Force, while assisted by members of the New York State Police Special Investigations Unit, Immigrations Customs Enforcement, and U.S. Border Patrol, conducted an undercover operation that resulted in the arrest of several females on charges ranging from prostitution to and being in the United States illegally.

A search of the residence yielded approximately 290 grams of crack/powder cocaine, over \$12,000.00, jewelry, shotgun and switchblade knife. The target of the investigation was charged with Criminal Possession of a Controlled Substance in the First Degree and Criminal Possession of a Weapon in the Fourth Degree.

Because of our ongoing positive relationship with the Division of Criminal Justice Services, approximately one third of our training was conducted at no cost. Our facility is regularly complimented on by their staff, the instructors they provide and the many visitors we receive as a result of hosting DCJS training.

# Community Policing Division School Resource Officer

The Community Policing Divisions employs one full – time Deputy. This Deputy is responsible for all Community Service Projects as well as serving as a full time School Resource Officer. The School Resource Officer program is a collaborative effort by certified law enforcement officers, educators, students, parents and the community to offer educational programs in the schools to reduce crime, drug abuse, and violence and provide a safe environment. It is the responsibility of the Deputy to focus on the needs of the school and assist the administration in accomplishing their goals.

The School Resource Officer is committed to promoting a concept of school based law enforcement. This TRIAD concept allows the School Resource Officer to act as a Teacher, Counselor and Law Enforcement Officer. School Resource Officers work with students, parents and school staff on a daily basis. The Deputy is required to develop and teach lessons to students on numerous subjects. Officers also assist students, parents and staff as counselors. Counseling sessions may be for behavioral problems or for persons in crisis. The Deputy talks to students regarding careers in Law Enforcement. The Deputy also assists the school in their disaster planning issues. They conduct investigations of incidents in and around the school. They also make any arrests, as a result of these investigations.

The Broome County's School Resource Officer works in the Maine Endwell School District, as well as the Chenango Valley School District. This partnership of law enforcement, school district, parents and the community, provides a safe and successful learning environment.

#### **School Resource Officer Advancement**

For 2011, the School Resource Officer has been utilizing a "slick top" car, meaning it has no light bar on the roof. This was set up for the School Resource Officer to blend in with traffic and other vehicles more, to catch motorists passing school buses and speeding in school zones. This patrol car has all the normal capabilities as a regular patrol car such as a computer, printer, radar, and other traditional police equipment. This position is still proactive, in sense of responding to more priority calls near or around the school that the Deputy is in. In 2011 the School Resource Officer has increased the number of tickets for people who have passed stopped school buses with red lights flashing. The tickets rose from 5 issued in 2010 to 23 issued in 2011. School districts state that they have seen a significant rise in illegal school bus passing's in the last two years. The Sheriff's Office is committed to try and combat this from happening and keeping Broome County students safe.







### **Neighborhood Watch Programs**

The Broome County Sheriff's Office continues to work with the citizens within the County, helping them establish Neighborhood Watch groups. This program encourages citizens to be active within their neighborhood in preventing crime and assisting the police by being good observers in the community. The Broome County Sheriff's Office added one new Neighborhood Watch community to bring the total up to 23 groups.



### **Safe Senior Programs**

The community policing division educated over 50 seniors this year on the issues of telemarketing fraud, investment scams, auto safety and theft prevention. Programs were offered at local senior centers and housing and area churches. Many donations from area businesses provided the Sheriff's Office to purchase several hundred "Senior Safe" pamphlets that were handed out to various seniors in Broome County.

#### Grants

The Community Policing Office authored 3 grants for the 2011 year. These grants totaled \$43,129. The grants were provided through the Governors Traffic Safety Committee.

<u>Selective Traffic Enforcement Program</u> (STEP). This \$24,129.00 grant paid for additional patrol hours on Broome County Highways. Deputies used these hours to curb aggressive driving habits, thus lowering motor vehicle accidents attributed to aggressive driving. Along with the additional hours, we were able to purchase traffic enforcement equipment for patrol vehicle. This included advanced and up to date radar systems, and two new laser guns for stealth mode enforcement.

<u>Buckle Up New York</u> (BUNY Campaign). This grant was for a total of \$9,150.00, and was used to place additional patrol hours on Broome County Highways to curb the nonuse and misuse of seat belts.

<u>Child Safety Seat Grant</u>. (CPS). The grant of \$9,500.00 allowed the Sheriff to purchase new child safety seats and distribute them to needy families in Broome County. This grant allowed for Deputies to give new car seats away to motorists whose car seats were either damaged, expired or the wrong size for the child.







### **Law Enforcement Explorer Program**

The Sheriff's Office hosted a new group of Law Enforcement Explorers in 2011 with a total of 16 Explorers. Explorers learned the basic fundamentals of law enforcement through various classes. Several guest speakers came to teach about different law enforcement occupations including An Officer from the NYS D.E.C.., and a K-9 Deputy. The post is held from September through late June.



# **Speed Trailers**

The Broome County Sheriff's Office continues to utilize two Speed Trailers. The Speed Trailers are self-contained units that are equipped with their own power source and speed-measuring equipment. When they are set up in a specific area, they display vehicle speeds. The trailers are pre-programmed to light up the speed of the vehicle and if the vehicle exceeds a pre-determined speed, the unit will flash the speed and inform the driver of their violation. These Tracker Trailers have proven to be very effective in curbing speeding vehicle problems. The trailers were moved quite often in 2011, due to an increased number of speed related complaints. Once the trailers are set up, it is announced in roll call for Deputies to not only check on the trailers, but to provide extra patrol in the areas of request. The speed trailers were deployed in more than 30 different locations in 2011.

### **IDENTIFICATION DIVSION**

The Identification Division is responsible for the maintenance of criminal records of the Broome County Sheriff's Office. In addition, this Division provides numerous services to the public, including fingerprinting for adoptions, permits, job applications, security clearances, the issuance of personal identification cards, records checks for several Broome County agencies, arson background checks for volunteer firefighters, registration of sex offenders within Broome County and the maintenance of the sex offender registry.

Contained within the Identification Division is the Pistol Permit Office, which handles all aspects of issuance and maintenance of pistol permits for the public. This Division is staffed as follows:



### CORRECTION DIVISION

The Broome County Sheriff's Correctional Facility is not only committed to the care, custody and safe treatment of its prisoners but also to the protection of the citizens of Broome County. This could not have been more evident than the response the Correction Division made during the flooding which devastated a large portion of Broome County in September of 2011. A large number of Correction Officers worked 12 – 16 hour shifts. These officers manned fixed posts in affected areas. This was to ensure the safety of people by preventing them from entering these areas. They supervised inmate work crews working in affected areas. The work crews were sent to assist with sandbagging details and cleaning rescue shelters once they were closed down. Once the waters receded the work crews removed the sandbags. When it was safe for affected areas to be occupied, work crews assisted in cleaning the streets. The facility's laundry service was utilized to launder members of the National Guard uniforms.

Several capital projects were completed in 2011. The showers in B, D and F pods were completely resurfaced. This process involved removing the current surface and replacing it with fresh paint and applying a more durable sealant. There is a lifetime warranty on the new surface. New carpeting was installed in H-Pod. New tables were installed in the programs room for all of the housing units insuring a safer living environment. Two new vehicles were purchased. A Ford Fusion for the Field Intelligence Officer and a Ford Super Duty extended cap truck for the Corrections Training Coordinator. The facility began evaluating and testing teleconferencing systems. Two units were installed in A-Pod and in a non-contact visiting room. This will result in a cost savings to the county. Travel time to the facility will be reduced. Attorneys from the Public Defenders Office and Broome County Probation Officers will be able to see their clients from their computers in their offices.

Throughout the course of the year, the administration worked to implement and revise the best course of action that would provide the most effective use of our critically-limited resources to get the "Best Bang for the Buck". Through innovative thinking and strategies our efforts have paid-off. Overtime was drastically reduced. The dollar amount spent on overtime was reduced significantly and was under budget in the year 2011. This was a great accomplishment showing the commitment the supervisory personnel made towards running a leaner cost effective operation, all the while maintaining a safe and secure facility.

- Operate a cost effective and staff efficient correctional facility;

### **Corrections Training Unit 2011**



#### **Medical Services**

The Health Services Unit of the Correctional Facility has a comprehensive medical unit approach that combines both the medical services and forensic mental health service under one provider. Correctional Medical Care is contracted with the county to provide these services. The facility and county has benefited by this continuity of care. The unit is working very well in meeting the demanding needs of a growing population, while continuing to control costs.

The unit has worked hard in maintaining the high level of services demanded by the Sheriff's Office. Both the medical and mental health are accredited by the National Commission Correctional Health Care (NCCHC). Accreditation is the process of external peer review in which NCCHC, a private, not-for-profit organization, grants public recognition to correctional institutions that meet its nationally accepted <u>Standards for Health Services</u>. Through the accreditation process, NCCHC renders a professional judgment regarding health services provided and assists correctional facilities in their continued improvement.

#### Criminal Investigations Unit Corrections Division

The Criminal Investigations Unit is a sub unit of the Corrections Division, made up of select officers trained as investigators. These officers receive two weeks of criminal investigations training as well as periodic specialized training in areas that are relevant to their duties.

Currently, there are fourteen officers assigned to the unit plus one Sergeant assigned as Direct Supervisor and one Lieutenant as Direct Command oversight for the unit, with the Captain and Major of the division completing the command structure.

CIU is tasked with the responsibility of investigating any criminal activity that occurs within the Sheriff's Correctional Facility and the arrest and prosecution of the perpetrators. The unit is also responsible for the collection, verification, and dissemination of gang intelligence as well as maintaining the Sheriff's Gang Database. This database is a resource for county wide law enforcement on gang activity and gang intelligence.

The Supervisor of the unit is tasked with conducting background investigations on all potential new officer hires and civilian employees for the Corrections Division. Further, the Supervisor is responsible for all divisional internal investigations, acting as Internal Affairs for the Corrections Division, the Captain and Major of the division are in direct command of these responsibilities conducted by the Supervisor.

The unit also functions as an arm of Criminal Intelligence, assisting local Detective Divisions and other police agencies with relevant information for ongoing investigations or identification purposes.

The following is a breakdown of the unit's activity for the year 2011.

- 49 Closed by Arrest
- 17 Closed by Investigation
- 1 Agency Assists
- 4 Search Warrant

Total charges are not mutually exclusive. Charges can overlap on the same criminal act. For instance, an inmate may have had felony and misdemeanor charges on the same arrest.

#### **Warning Letters Written:**

16 Warning Letters were issued. These letters are sent to prisoners warning them to cease all contact with persons who are being harassed or annoyed by them. This letter is sent prior to opening a Harassment charge against the prisoner.

#### Security Risk Group/Gang Management

Part of the responsibility of the Correction Investigations Unit is to proactively collect, evaluate and disseminate security related gang intelligence that exists among the offender population. The unit works closely with law enforcement agencies in gang related crimes. Not only to prevent potentially dangerous incidents within the correctional facility, but also as a proven benefit to public safety. In 2011 we housed inmates who had gang affiliations with such groups as the Bloods, Crips, Latin Kings, Arien Nation, Neta's, and Outlaw Motorcycle Gangs. Members of the unit interviewed 52 security risk group affiliates. The individuals interviewed were entered into the county wide Security Risk Group data base which is maintained by the Correction Investigations Unit.

A total of 6 officers were hired as a result of the background investigations and 9 candidates were not hired as a result of the background investigation.


#### INMATE GRIEVANCE PROGRAM

New York States Minimum Standards for correctional facilities states: "In order to provide an effective and impartial procedure for the timely resolution of inmate complaints, the chief administrative officer of each local correctional facility shall establish, implement and maintain a formal inmate grievance program. Every effort shall be made to resolve inmate complaints in an informal manner." The Correction Division has one full time officer completely dedicated to processing and resolving inmate grievances

The term "grievance" is defined as a written inmate complaint concerning either written or unwritten facility policies, procedures, rules, practices, programs or the action or inaction of any person within the facility. The Major ensures that each grievance is investigated to the extent necessary by the grievance officer. Failure to supply sufficient information or evidence within two days shall be cause to deny the grievance. Grievances regarding dispositions or sanctions from disciplinary hearings, administrative segregation housing decisions, issues that are outside the authority of the chief administrative officer to control, or complaints pertaining to an inmate other that the inmate actually filing the grievance are not grievable and may be returned to the inmate by the grievance coordinator. Such grievances may not be appealed to the chief administrative officer or the Citizens' Policy and Complaint Review Council (Appeal to the Commission of Correction). If the inmate decides to appeal the decision of the facility pertaining to a particular grievance, a copy of the grievance shall be forwarded to the members of the Council for their review. If such determination is in favor of the grievant as a matter of law, the chairperson of the Citizens' Policy and Complaint Review Council shall direct the chief administrative officer to comply with the grievance and provide an appropriate remedy.


#### INMATE DISCIPLINARY PROCESS

The position of hearing officer is vital to the safe and secure operation of the facility. The staff that makes up the team ranges from the line officer, the programs Sgt., security lieutenants, and the jail administrator. This structure provides for timely assessment of the inmates actions along with lawful due process. Jails must be able to respond to an infraction of their rules quickly and decisively. But the courts insist that the disciplinary process follow certain steps, it does not require courtroom-like formality. A process respected by both staff and inmates alike benefits the institution.



### Weekender Work Program

As in the past years the Weekend Work Program continues to provide a valuable asset to the Broome County community. This is fulfilled by using county sentenced inmates in community service operations in Broome County. As you may or may not be aware the inmates are sentenced to weekends only. They report to the correctional facility on Saturday & Sunday at 8:00 am and are finished at 4:00 pm, at which time they go home. They do this each and every weekend until the time the Judge gave them is completed. When an inmate is sentenced by the court to work on the program, instead of serving their sentence in the jail they report to the correctional facility and go out to work with an officer in a designated area within the county. They sign an agreement in court to follow all the rules given to them, or they risk being violated by the court and resentenced to what is called straight time. Straight time is when they would have to serve their entire sentence in the correctional facility. By not having inmates in facility for lesser charges, helps to save the county money in these trying economic times. This is accomplished several ways. First, there is no expense by not having to board the inmates in the facility. Second, the inmate does not lose the job they may already have thus making them more productive in society. The weekender work program is a program available to any "notfor-profit" groups in Broome County. By having this program it has helped put back

valuable hours of labor into the community from individuals who have committed minor crimes therefore being cost effective by not having to pay employees to accomplish this work.

### **CIVIL DIVISION**



2 Civil Deputies 2 Keyboard Specialists

The Broome County Sheriff's Office Civil Enforcement Division is responsible for the enforcement of all civil processes in Broome County which include Summonses, Property Executions, Evictions, Income Executions and Subpoenas just to name a few. The Courts in Broome County and the surrounding counties depend on our Deputies to handle matters received from various Towns, Cities, Supreme, Surrogates and Family Courts. Our division often receives Orders of Protections, Summons and Petitions and other orders from all counties in New York as well as other states requesting us to affect service for them within our county.

In the year 2011 the Civil Division brought in 6,874 cases. The Civil Division processed over 800 Summonses, 861 Evictions, 68 Property Executions and 1,680 Income Executions. Family Court services which include neglect, juvenile delinquency cases, support petitions, orders of protection, sexual abuse petitions, modification hearings, and other kinds of orders and petitions totaled 2,633 services. A more detailed breakdown of the services is included in this report.

When attempting to effect service, our Deputies spend vast amounts of time investigating and locating people to be served. Incorrect addresses, names and information are given to our office and it becomes a time-consuming process to search for the correct information. Oftentimes the Deputies must send inquires to local Post Offices or question friends, relatives and neighbors of the address in which they must service. They

will also investigate former employers to seek current information or research names in the office from the computer and other resources that are available to them. As a result of their countless hours of investigation, 6,593 services out of 6,874 were served only 281 services were unable to be served. 87 services were returned at the request of either the courts or attorneys.

The Civil Enforcement Division handles numerous warrants of evictions for Broome County. The process for enforcing an eviction would include the Deputies overseeing the actual removal of a tenant's personal property. It would also include the enforcement of both the landlord and tenants rights and seeing that proper procedures and laws are being followed. A Deputy may spend anywhere from 1 to 4 hours and sometimes more on each eviction depending upon the situation. On the occasion of enforcing a warrant for a business such as a restaurant or an established business, our Deputies have spent 6 to 10 hours assuring the removal of equipment, furniture, and inventory.

In January of 2011 new legislation was passes by Gov. Cuomo regarding the enforcement of money judgments and exempt property. This legislation changed how Sheriff's can enforce personal property levies. As a result of this legislation we saw a decline of enforcement on vehicle seizures and real property sales, not only in Broome County but State wide. The flood of 2011 also caused a decline in revenue as well as unemployment. Attorneys as well as pro-se litigants were prioritizing how to spend their money. People were out of work so Income Executions enforcement decreased.

Revenue brought in for services in 2011 was \$134,996.42 for Sheriff fees. This included mileage which had an increase of \$21,454.42 from the previous year, \$154, 777.56 for poundage totaling \$289,773.98 an overall increase of \$27,547.26. This money is all turned over to Broome County. The Civil Division took in a total amount of \$403,964.48 this includes money collected and dispersed to Judgment Creditors

The County Attorney's Office, Real Property Tax, The District Attorney's Office, the County Health Department, Support Collection and the Department of Social Services seek the Civil Enforcement Office in processing and servicing their legal process and violation notices. These county offices also seek assistance in service and procedure of Civil Law.

### **BUSINESS OFFICE**

The Business Office maintains all departmental financial functions such as Cash Receipts, Cash Disbursements and Accounts Payable. The accounts involved are Commissary/Inmate Funds, Bail & Fine Funds, Pistol Permits & Identification Funds, Records Funds and all Civil Account Funds. The staff assigned is as follows:

One Principal Account Clerk
One Senior Account Clerk/Typist
Two Account Clerk/Typists

The Business Office maintains the payroll records for the 236 employees of the Sheriff's Office, as well as the input, auditing and disposition of paychecks, and employee attendance records.

Worker's Compensation files and all necessary reports are also maintained in the Business Office. In 2011, the business office processed 24 Worker Compensation Claims. Of these, 12 were from Highway Patrol and 12 were from Corrections.

Purchase order and claim voucher records are maintained through an Excel program, which allows for up-to-date data needed to make necessary financial decisions. In 2011, 311 purchase orders and 912 claim vouchers were processed. The work has increased significantly (doubled) due to the new financial systems put in place in 2010 by the county.

Transactions and funds handled as bails and fines amounted to 783 and \$834,421.00.

The Business Office processed transactions for open civil accounts, of which 1,680 were new income executions and 65 were new property executions. This represents a 12.4% decrease over 2010. Income executions that required additional service upon employers (generating additional fee income) amounted to 1,281 cases. 1,656 cases were closed as satisfied, nulla bona's and balance nulla bona's.

The number of receipts processed in 2011 was 24,875 which are approximately 96 payments a day. Disbursements relevant to these accounts amounted to 2,727 which is approximately 227 per month. Sheriff's fees (Poundage – 5% of all payments received) amounted to \$154,777.56. Fees generated for Income and Property Executions amounted to \$14,190.50.

All inmates and commissary funds are processed through the Business Office. Daily funds are received, deposited and posted to the inmate accounts through the Swanson Banking System. \$523,315.59 was receipted through the inmate funds account and \$448,265.52 was disbursed. Audits are conducted using the automated system and balanced to the manual control accounts on a weekly basis. Swanson Corporation processes all commissary orders and delivers the orders to the facility. This procedure

has helped diminish inventory shortages and employee expenses. Receipts amounting to \$112,443.61 were processed through the commissary funds account and \$77,502.07 was disbursed in 2011. Net sales generated from the commissary account for 2011 were \$306,261.17 and commissions from these sales amounted to \$91,113.

### **RECORDS DIVISION**

The Records Division of the Broome County Sheriff's Office is responsible for the recording and maintaining of all official records and documents relative to the police operations of the Broome County Sheriff's Office. This Division is responsible for entering all Incident/Case and Accident Reports investigated by the officers of the Broome County Sheriff's Office into the AS-400 Computer System and filing monthly reports to the Division of Criminal Justice Services in Albany using the Incident Based Reporting System. Personnel that are assigned to the Records Division are as follows:

- 1 Stenographic Specialist
- 1 Keyboard Specialist

The members of this Division are responsible for providing the public with copies of Motor Vehicle Accidents, New York State Incident Reports and photographs as required. In 2010, we began offering a new service where motor vehicle accident reports are available for purchase on-line. Accident and theft reports are also available through the Records Office at a fee of 25 cents per page. More sensitive reports are required to be requested through the County Freedom of Information Office. In 2011, the Records Division processed 281 Freedom of Information Requests and provided over 2200 reports to several other agencies, including the District Attorney's Office, the Department of Social Services, the Probation Office and the New York State Parole Office.

Additionally, the Records Division is responsible for providing an alarm permit to the residents and businesses in our jurisdiction who maintain a burglar alarm on their premises. This Division also maintains an account of all avoidable alarms occurring at these locations, and provides billing as required. There is no fee for an alarm permit; however, fees do come into effect for excessive avoidable alarms within each calendar year. A breakdown of these fees is as listed below:
