Proposals will be evaluated by Broome County DPW using the following:

A. EQUIPMENT REMOVAL: Remove lightbar, siren speaker, 2 grill lights, headlight flasher, 2 front strobes, 4 rear strobes & power supply, arrowstick, arrowstick control, 2 prisoner barriers, console, outlets, flashlight holder, 2-way radio & antenna, siren/switch unit, shotgun mount and rear rifle mount. Disconnect and remove all user wiring and make any connections to return car to civilian use. Remove computer, antenna, modem, hub, scanner, printer and all cables for transfer into new vehicle. Remove radar unit completely including remote. Remove camera system and all related parts. All removed parts will be returned to Fleet.

Removal cost per hour \$ 30.00 x Total hours 3 = Total labor cost for removal \$ 90.00

B. EQUIPMENT INSTALLATION: Install lightbar, 2 red LED grill lights, 2 white LEDs on grill as a headlight flasher, 2 front corner white LEDs, siren speaker, 4 rear LEDs in tail lights, arrowstick in rear window, 2 LEDs on tailgate, console, siren/light controller, arrowstick controller, cup holders, 2 way radio & antenna, computer, laptop mount, printer box & printer, scanner, chargeguard, USB hub, computer antenna. Install radar unit with antennas in front & rear and box on dash. Make all connections to power and properly fuse each device. Install Digital Ally video camera in vehicle completely. All devices to turn off with ignition. Computer to be wired to turn off with chargeguard. Install prisoner barrier, in accordance to specifications, behind front seat and with rifle/shotgun mounts inside the barrier. Gun mounts to be controlled by a timer switch in siren/light controller. Install prisoner barrier behind rear seat, in accordance to specifications. Letter and stripe vehicle according to Sheriff's Department plans and specifications.

Installation cost per hour \$ 31.00 x Total hours 18.0 = Total labor cost for installation \$ 558.00
